RIDE ON LA SUBSIDIZES THE FEE FOR SERVICE FOR ALL CLIENTS BUT ALSO GIVES SCHOLARSHIPS AT FURTHER REDUCED RATES RANGING FROM FREE TO 1/2 OF PUBLISHED RATES.
